MINUTES – July 3, 2023

The Board of Aldermen of the Town of Gibsonville met at 7:00pm for a regular meeting in the Gibsonville Town Hall. The meeting was called to order by Mayor Protem Shepherd. Alderpersons Owen, Crisp, Dean, and Fanelli were present. Mayor Williams was absent. Ben Baxley, Town Manager, Gina Griffeth, Town Clerk, Bob Giles, Town Attorney, James Todd, Fire Chief, Lt. Scott Shelton, Rob Elliott, Public Works Director, and Troy King, Utility Superintendent, were present. There were several members of the public present. The board meeting was live streamed on Facebook and available via landline for those unable to attend.

Mayor Protem called the meeting to order and lead the pledge of allegiance. Alderman Owen led the invocation.

Public Comments

George Clancy of 314 Timbergate spoke to the board regarding water quality concerns. He stated that he had his water tested by Meritch Lab which came back positive for cyanide. The sample was taken from a humidifier which was also brought in for the board to see. He asked that water samples be taken and tested in the Timbergate area.

Troy King of Public Works stated that he reached out to the City of Burlington today. The allowable cyanide level per the State is 0.2mg/L. Burlington has set their allowable limit at 0.05mg/L. Both of Burlington's water plants test lower than 0.05mg/L.

Rob Elliott stated that they can test multiple houses on Timbergate. The park bathroom near Timbergate is also one of the town's normal Bac-T testing sites. Testing could not be done earlier this week due to the lab being closed for the 4th of July holiday.

Approval of Agenda

Alderman Crisp, seconded by Alderman Owen, made a motion to approve the agenda. The motion passed unanimously.

Approval of Minutes

Alderman Owen, seconded by Alderman Crisp, made a motion to approve the minutes of June 20, 2023. The motion passed unanimously.

Annexation Petition – 529 NC HWY 61 South

Owner Nasser Massry (Starlight Construction, LLC) has submitted an annexation petition for 529 NC HWY 61 South (Guilford County Parcel ID 104350 consisting of 0.91 acres). The board will need to direct the Town Clerk to certify the sufficiency of the petition and certify the results to the board. The board will also need to set a public hearing for August 7th.

Mayor Protem Shepherd, seconded by Alderman Owen, made a motion to direct the clerk to certify the sufficiency of the petition and set the public hearing for August 7th. The motion passed unanimously.

Resolutions to accept an offer of American Rescue Plan funding

These resolutions are needed to accept American Rescue Plan funding from the NC Division of Water Infrastructure. Each offer is in the amount of \$200,000. The projects to be funded are an Asset Inventory and Assessment study for the town's water infrastructure and an Asset Inventory and Assessment study for the town's sewer infrastructure.

Mayor Protem Shepherd, seconded by Alderman Owen, made a motion to approve the resolutions accepting American Rescue Plan funding. The motion passed unanimously.

RESOLUTION BY THE TOWN OF GIBSONVILLE TO ACCEPT AN OFFER OF AMERICAN RESCUE PLAN FUNDING

SECTION VI. TAX RATE ESTABLISHED

An ad valorem tax rate of \$0.49 per \$100 at full valuation is hereby established as the official tax rate for the Town of Gibsonville for the fiscal year 2024. This rate is based on a total valuation of property of \$1,087,318,941 and an estimated collection rate of 99.00%.

SECTION VII.

Charges for services and fees by Town Departments are levied in the amounts set forth in the Fee Schedule (See Attachment A).

SECTION VIII. SPECIAL AUTHORIZATION - BUDGET OFFICER

A. Budget Officer shall be authorized to reallocate departmental appropriations among various object of expenditures as he believes necessary.

B. The Budget Officer shall be authorized to effect interdepartmental transfers, in the same fund, not to exceed 10% of the appropriated monies for the department whose allocations is reduced. Notation of all such transfers shall be made to the Board on the next succeeding Financial Report.

C. He may make interfund loans for a period of not more than 60 days.

D. Interfund transfers, established in the budget document may be accomplished without recourse to the Board.

SECTION IX. RESTRICTION - BUDGET OFFICER

A. Interfund transfer of monies, except as noted in Section VI. Shall be accomplished by the Board authorization only.

B. The utilization of any contingency appropriations shall be accomplished only with Board authorization.

SECTION X. UTILIZATION OF BUDGET ORDINANCE

This Ordinance Amendment and the Budget Document shall be the basis of the financial plan for the Gibsonville Municipal Government during the 2024 fiscal year. The Budget Officer shall administer the budget and shall insure that operating officials are provided guidance and sufficient details to implement their appropriate portion of the budget. The accounting section shall establish records which are consonance with the Budget and this Ordinance and the appropriate statute of the State of North Carolina.

Clearscapes Schematic Design and Design Development Proposal – Gibsonville Public Library Reports

Clearscapes Architecture + Art completed the Concept Design phase of the Gibsonville Public Library Project in May of 2023. They have provided a proposal for the next steps, Schematic Design and Design Development, in the amount of \$300,000. This funding has already been allocated by the town to the project ordinance. Subsequent phases to include Construction Documentation, Permitting, Bidding, and Construction Administration will continue forward as more funds are made available to the project and the owner's written approval to proceed is received by the design team.

Alderwoman Fanelli asked if the proposal included bid documents.

Ben Baxley replied that it did not and those items would be further down the road.

Alderman Shepherd, seconded by Alderman Crisp, made a motion to approve the Clearscapes proposal. The motion passed unanimously.

Town Manager – Ben Baxley stated that the Gibsonville Development Advisory Committee has an opening. The vacancy will be advertised on the town's website and Facebook page and will close on August 4th. He commended Parks & Recreation, Public Works, the Police Department and Fire Department for their parts in the Old Fashioned 4th and concert on the greens on Saturday. He reminded everyone that town offices are closed on July 4th. Tuesday's garbage route will be collected Wednesday and recycling will run on a normal schedule.

Mayor – Mayor Williams was absent.

Board Members – Alderman Dean asked about the old school and imposing fines.

Ben Baxley replied that the fines have been in place since February.

Mayor Protem Shepherd, seconded by Alderman Owen, made a motion to adjourn. The motion passed unanimously. The meeting adjourned at 7:32pm.
