- **7. Resolution to Accept an Offer of American Rescue Plan Funding** The Town of Gibsonville has been approved for American Rescue Plan (ARP) funding from the State Fiscal Recovery Fund in the amount of \$500,000. This resolution is needed to accept said funding from the Division of Water Infrastructure. Funding will be used for a new elevated water tank.
